Summary

HitecVision New Energy Fund 2 (the **Fund**) is a closed-ended, alternative investment fund seeking commitments from professional investors only.

The Fund's sustainable investment objective is to contribute to climate change mitigation by investing in portfolio companies with the potential to contribute to reducing global greenhouse gas emissions and/or increasing renewable energy capacity and production. The Fund will make investments in or linked to the energy sector, except for exploration, production, transportation and storage of coal, oil, natural gas and nuclear power (however, this shall not exclude investments in or linked to carbon capture, use or storage (**CCUS**))).

All investments of the Fund will be aligned with the Fund's sustainable investment objective. Monitoring of the sustainability indicators used to measure the attainment of the sustainable investment objective is done by regularly obtaining data directly from portfolio companies. The attainment of the Fund's sustainable investment objective is not expected to be affected by limitations to methodologies or data.

Pre-investment due diligence and post-investment engagement are applied to attain the Fund's sustainable investment objective as further described in HitecVision's responsible investment policy (the **Responsible Investment Policy**).

Translations of this summary is included in Appendix 1.

No significant harm to the sustainable investment objective

For each portfolio company, HitecVision conducts a materiality analysis to analyse and grade potential ESG issues. Each potential investment will be screened against the principal adverse impacts on sustainability factors prior to making an investment decision. In addition to monitoring and reporting on adverse impacts, several other control mechanisms apply to ensure no significant harm, including, *inter alia*, ESG due diligence and portfolio engagement.

During the ownership period, all investments shall report to HitecVision on a quarterly basis on ESG issues, including the indicators for principal adverse impacts on sustainability factors. Based on the quarterly reporting, HitecVision will ensure that no investments cause significant harm by quantitative and qualitative assessments.

All of the Fund's investments must align with the OECD Guidelines for Multinational Enterprises

and the UN Guiding Principles on Business and Human Rights including the principles and rights set out in the eight Fundamental conventions identified in the Declaration of the International Labour Organisation on Fundamental Principles and Rights at Work and the International Bill of Human Rights.

Compliance with these internationally recognised principles is part of the due diligence process applied to potential investments, where HitecVision seeks to ensure that the potential investments have implemented adequate governance models relating to, among other things, environmental, social and employee matters, respect for human rights, anticorruption and antibribery matters. As part of this process, HitecVision not only ensures the presence of adequate governance models but also assesses whether the potential investments' own due diligence practices align with the standards set by the OECD and UN Guiding Principles.

Sustainable investment objective of the financial product

The sustainable investment objective of the Fund is to contribute to climate change mitigations, by investing in and building companies that support the energy transition. To attain the sustainable investment objective, the Fund shall invest in portfolio companies with the potential to contribute to reducing greenhouse gas emissions and/or increasing renewable energy capacity and production. The Fund will invest in and build companies focused on renewable power and electrification, sustainable fuels, as well as circular and efficient energy systems.

Investment strategy

The Fund shall seek to make equity and equity-related investments in or linked to the energy sector, except for exploration, production, transportation and storage of coal, oil, natural gas and nuclear power (however, this shall not exclude investments in or linked to CCUS).

The Fund will seek to invest in opportunities in the European energy transition and focus on investments across three core energy transition investment themes:

- **Renewable power and electrification.** Increase renewable power capacity to decarbonise the power mix and electrify industry and transport
- **Sustainable fuels .** Decarbonisation of hard-to-abate sectors such as marine, aviation, steel and cement, requiring development of sustainable fuels.
- **Circular and efficient energy systems.** Creating more inter-connected and circular systems, focused on energy efficiency, re-use and recycling.


The governance practices of a potential portfolio company, including with respect to sound management structures, employee relations, remuneration of staff and tax compliance, will be assessed in the due diligence process. All portfolio companies will be required to comply with

applicable laws, rules and regulations in the markets in which they operate, including environmental, labour, anti-corruption and anti-money laundering laws and regulations.

When working with the portfolio companies, HitecVision places responsibility for ESG issues with the companies' boards of directors. Where HitecVision holds controlling interests in a portfolio company, HitecVision will implement its governance model for portfolio companies, which includes a set of board guidelines/rules of procedure and a model compliance programme, developed by HitecVision.

Proportion of investments

All of the Fund's investments in portfolio companies will be aligned with the Fund's sustainable investment objective. However, the Fund is likely to have some cash or cash equivalent holdings for ancillary liquidity purposes. The Fund is committed to making a minimum 30% proportion of investments with an environmental objective aligned with the EU Taxonomy.



All exposure is expected to be direct.

Monitoring of the sustainable investment objective

For a minimum of 30% of the Fund's investments, the alignment of the portfolio companies' activities with the requirements of the EU Taxonomy climate change mitigation objective will be a way to show the attainment of the Fund's objective. For the remaining investments, sustainability indicators used to measure the attainment of the Fund's sustainable investment objective include (i) renewable energy (electricity and fuels) capacity built or contracted to be built measured in MW, (ii) renewable energy (electricity and fuels) generated measured by MWh, and (iii) current and future greenhouse gas emissions avoided and/or reduced due to the activities of the portfolio companies measured in CO₂ equivalents.

The sustainability indicators and other relevant KPIs, such as the principal adverse impacts, are

monitored through regular engagement with and reporting from portfolio companies and are generally reviewed and assessed internally. External third-party verification of select portfolio companies of HitecVision is performed annually, which in any given year may include data reported from portfolio companies of the Fund.

Methodologies

In order to measure the attainment of the sustainable investment objective of the Fund, the potential for greenhouse gas emission reductions and/or increased renewable energy capacity and production of each investment opportunity is assessed and quantified, where feasible. For Taxonomy-eligible activities, the contribution to climate change mitigation will, where practically feasible with regards to data availability, be determined by use of the technical screening criteria in the EU Taxonomy for environmentally sustainable economic activities.

To ensure transparency and enable emission comparison, methods for calculating and accounting emissions will be based on globally recognized guidance, such as the GHG Protocol or equivalent. Other than that, relevant methodologies to measure the Fund's attainment of the sustainable investment objective will be selected for each investment, in all cases focusing on the sustainability indicators for the Fund.

Data sources and processing

- a) Data are expected to be provided directly from the prospective or actual investee companies.
- b) Data quality is expected to be ensured through regular due diligence activities.
- c) Data will be processed in-house.
- d) Data collected to measure the sustainability indicator related to avoided and/or reduced GHG emissions will necessitate the use of certain estimations. Other than that, it is expected that only a minor proportion of data will need to be estimated.

Limitation to methodologies and data

As the methodologies will be selected and tailored to each investment, it is not possible to state any general limitations. As far as possible, the methodologies selected will be based on standard industry practice. This also includes the methodology to collect data related to avoided and/or reduced GHG emissions, which is largely expected to be based on estimated data. Such limitations are not expected to affect the sustainable investment objective of the Fund.

Due diligence

Due diligence is performed in accordance with HitecVision's due diligence procedures and the Responsible Investment Policy. HitecVision will assess how potential investments align with the

sustainable investment objective of the Fund. This sustainability assessment requires investments to demonstrate i) potential for contributing to reducing greenhouse gas emissions and/or increasing renewable energy capacity and production, ii) principal adverse impact indicators that ensure no significant harm to other environmental or social sustainable investment objectives, and iii) that good governance practices and social safeguards are in place.

Prior to making investment decisions, the investment team is required to complete a compliance checklist confirming alignment with the above-mentioned criteria. The compliance checklist is reviewed and assessed by HitecVision's compliance committee.

Engagement policies

Engagement with portfolio companies will be performed in accordance with HitecVision's regular procedures and the Responsible Investment Policy. To ensure transparency and facilitate progress on ESG issues, portfolio investments are required to deliver quarterly ESG reports to HitecVision and actively participate in biannual ESG meetings with the team.

Attainment of the sustainable investment objective

The Fund will not use a reference benchmark.
